These revised versions are currently **near final** versions which will be replaced in the next couple of days with **final** versions which take effect on 31 December 2006. A further e-alert will be circulated when the final versions are available.

The profession considered what changes to the GNs might be appropriate as a result of the proposals in PS06/14 and shared its work with the BAS as input to the BAS's thinking.
