### Who we are

The IFoA Foundation is a registered Scottish charity (SC049518). The IFoA Foundation was formed by the Institute and Faculty of Actuaries (IFoA) in August 2019 as an amalgamation of several previous charities under the IFoA. The Foundation's mission is to raise funds to support the actuarial community and to achieve the overall goal of 'Actuaries Supporting Others'.

The Foundation has three objectives:

- Rewarding Excellence Providing recognition, prizes and awards for excellence in actuarial examinations and academic research
- Supporting Our Community Giving bursaries and grants to university students, those studying the actuarial examinations and others in financial hardship
- Addressing Future Challenges Supporting the IFoA's public interest responsibilities and partnering with other charities on financial education The Foundation is dedicated to the encouragement, advancement and support of education, research and study in actuarial science and related subjects.

We are registered as a Data Controller with the Information Commissioner's Office (ICO) in the United Kingdom.

### How we manage personal data

The Foundation manages personal data in accordance with the relevant laws at all times. In line with the UK Data Protection Act and the General Data Protection Regulation personal data is:

- only processed where there is a specified legal basis for doing so;
- accurate at the point of collection, and kept up to date;
- only used for purposes compatible with those it was collected for;
- kept secure and available;
- only kept for as long as it is needed.

When collecting information the Foundation will only ask for data that is required to complete the task.

# Why we process your personal data, the data we collect and the lawful basis for processing

As a Charitable organisation the Foundation needs to collect and process the personal data of individuals that are:

- charity trustees or those otherwise engaged in the administration of the charity;
- active or prospective donors;
- enquiring about the Foundation;
- making applications for funding or in receipt of funding by the Foundation;
- administering bequests where the Foundation is a prospective or active beneficiary;
- suppliers of goods and/or services to the Foundation.

The Foundation engages with stakeholders across multiple channels of communication. Personal data is collected via correspondence, forms, notes of telephone discussions or meetings and interaction via social media.

The Foundation will only process your personal data where there is a specified legal basis for doing so. You can learn more about the data typically collected in the course of our activities and the legal basis in the indicative table below:

## When we share your data

### When we might transfer your data across borders

The actuarial community is a global one. By its nature the Foundation will, from time to time, transfer personal data between jurisdictions to facilitate the delivery of its objectives. This will always be done securely with appropriate safeguards in place.

### How long we keep your data

We retain personal data only for as long as is necessary to meet operational, legal or regulatory requirements. More information about our records retention principles are available upon request.

## When the use of your personal data is based on our legitimate interests

If we send you information based on our legitimate interests as a charitable foundation such as newsletters, updates on our activity, funding opportunities and notices of events you are able to opt out of receiving this at any time.

## Children's data

From time to time the Foundation may process children's data when awarding prizes for academic achievement or bursaries for study. In line with the guidance of the Information Commissioners' Office in the UK, 'children' are defined as persons under the age of 18. When the Foundation processes children's data the legal basis are the legitimate interests of the Foundation. Adequate safeguards are in place to ensure the data protection rights of under 18s are protected and their data kept secure.

## Your information rights

You have the right to:

- obtain a copy of any personal data we hold about you;
- correct any data we hold about you that is incorrect or out of date;
- ensure we dispose of any personal data we hold about you (once all legal and regulatory record keeping requirements have expired);
- restrict the processing your personal data;
- object to us processing your personal data;
- erase your personal data, where we no longer have a lawful basis or valid operational reason for holding it;
- request we send all or some of the personal data we hold about you to another organisation.

If you wish to exercise any of your information rights please contact the Foundation with your request.

## If you're unhappy with how we have used your personal data

Please contact the Foundation in the first instance in order to discuss your concerns. If required, you have the right to make a complaint to a Supervisory Authority about how we process your personal data.
