

## Contribute to the Innovation Lab

## Making your recording

When you make your recording:

- Focus on your views and experiences on one of the following three themes: the economy, planet or population
- Make sure your video is no longer than two minutes in length
- Ensure the total file size of your recording does not exceed 12mb in size
- Film in landscape, in a neutral and light space
- Try to find a quiet location with no background noise
- Keep the camera focused on you
- Film yourself using a stable surface e.g., if you are using your smartphone, please use a stand or ensure it's appropriately propped up.

Please send your video to innovationlab@actuaries.org.uk.

When you submit your video, please include a couple of lines stating what the video is about, along with your name, job title, company and IFoA member status.

## Please also note the following information

By submitting your video for publication on the Innovation Lab of the IFoA website you confirm that:

- (a) You (and/or other named contributors) are the sole author(s) of the content submitted and the content is not confidential in nature
- (b) The content you submit is original and has not previously been published or promoted (unless you specifically advise us to the contrary)
- (c) You haven't previously licensed the use of the content you submit



(d) So far as you are aware, the content submitted will not infringe any third-party rights, be defamatory or in any way illegal.

All views expressed by the contributor(s) remain the responsibility of the contributor. The IFoA does not accept responsibility or liability for views expressed in videos or related content.

By submitting your video to us, you are understood to be allowing us to publish the video on the IFoA's website. However, submitting a video does not automatically guarantee publication.
